MEMORANDUM OF COOPERATION

№01-295

Kyiv

8 of January 2020

The Ukrainian National Committee of the International Council on Large Electricity Systems CIGRE, the function of which is performed by the Public Association “International Council on Large Electric Systems CIGRE in Ukraine”, hereinafter referred to as the "CIGRE-Ukraine", represented by President Svetelik Alexander, on the one hand, and

Limited Liability Company «EKO PRO+», hereinafter referred to as the LLC «EKO PRO+», represented by Director Mykola Chabanyuk, on the other hand, hereinafter jointly referred to as the - «Parties», and separately as the - «Party»

have concluded this Memorandum of Cooperation and interaction on the following issues:

1. The Subject of the Memorandum.

1.1. Establishing partnerships and developing long-term, effective and mutually beneficial cooperation between the Parties, aimed at the development and integration of energy balancing and storage systems (Battery Energy Storage - BESS). The Parties intend to cooperate on the basis of equality, goodwill, respect, and trust, based on conventional practice.

1.2. By signing this Memorandum, the Parties agree to continue to act on the basis of parity and equality in the relationship and to make every effort to achieve the goals, which are provided in the Memorandum.

2. The Goals and Tasks of the Cooperation.

2.1. Development of state standards for the BESS systems on integration of the best world practice in the Power System of Ukraine.

2.2. Preparation of regulatory and technical documents for the BESS certification in Ukraine.

2.3. Elaboration of mechanisms for implementation of the BESS pilot projects - design and implementation.

2.4. Attraction of investments for implementation of the BESS projects in the Power System of Ukraine.

3. Final provisions.

3.1. The Memorandum shall enter into force on the date of its signature and shall remain in force indefinitely.

3.2. In the event of termination of this Memorandum, actions that have been initiated on the basis of the Memorandum and are not completed within the period of its validity, shall be continued and terminated in accordance with the terms previously agreed by the Parties, except when such measures cannot be completed.

3.3. This Memorandum does not imply any financial obligation for the Parties.

3.4. Any dispute regarding the interpretation or application of the provisions of this Memorandum shall be settled by the Parties through consultation and mutual agreement.

3.5. This Memorandum has been concluded in Ukrainian and English languages in four copies, each having the same legal force, two copies for each of the Parties.
